One Hundredth Annual Council
Diocese of Atlanta
Macon, Georgia, November 10-11, 2006

The One Hundredth Annual Council of the Diocese of Atlanta met in the Convention Center in Macon Georgia on Friday and Saturday, November 10th and 11th, 2006, pursuant to a resolution of the Ninety-ninth Annual Council. The Rt. Rev. J. Neil Alexander, Ninth Bishop Diocesan of Atlanta, was in the chair. The Macon Convocation, The Very Rev. Dan T. Edwards, Dean, was the host.

FIRST DAY
Friday, November 10th, 2006

Registration of Lay Delegates and Clergy Members began at 8:30 a.m.

Call to order, quorum call and organization for business

The Rt. Rev. J. Neil Alexander called the Council to order at 10:07 a.m. with prayer. He thanked the Macon Convocation for hosting the Council. The Secretary, The Rev. Herschel R. Atkinson, announced that a quorum was present based on registrations, but that two parishes, St. Andrew's in the Pines, Peachtree City, and St. Barnabas', Trion, did not register either Lay Delegates or Clergy Members. The Council was organized for business.

Agenda adopted

The Council unanimously approved adoption of the agenda as published.

Minutes of previous council approved

The Bishop announced that printed minutes of the previous Council could be obtained from the Secretary, and that those minutes had been published on the Diocese of Atlanta web site. The Council unanimously approved those minutes as published.

The Bishop explained that resolutions to be introduced amended procedures for the election of a Bishop Suffragan. He then called for approval of such election this date in order that the resolutions could be referred to legislative committees today and acted on the following day. The Secretary, The Rev. Herschel R. Atkinson, moved approval of the Bishop's request. The motion was seconded. A vote by show of cards was taken.

Committee reports

Canon 20 Review Committee: The Rev. Hendree Harrison Sr., Chair, reported on the results of Canon 20, revised in 2006. He referred to and commented on the written report of parish pledges to the Diocesan Mission and Ministry Budget for 2007.

Diocesan Treasurer: Gary Pannell, Treasurer, reported an excess of revenues over expenditures in 2006 to date of approximately \$28,000, a first time event during his tenure, but warned this may change by the end of the year.

Finance: Stephen Burnett, Chair, reported that the auditors' report was later than usual this year because the accounting basis was changed from modified accrual to modified cash basis. The auditors gave a clean opinion. The reserve fund that had been in peril is now climbing back to a decent level.

The Bishop thanked the Messrs. Pannell and Burnett for their work.

Bishop Child Heritage Circle and Bishop Child Legacy Society: Archdeacon Charles Gearing, Chair, reported on these new activities. They are designed to invigorate planned giving within congregations. Next year, Council will celebrate and acknowledge founding members.

Personal privilege

The Rev. Patricia Templeton, St. Dunstan's, Atlanta, noted that St. Dunstan's was listed in the written report of the Canon 20 Committee as not complying with Canon 20. She stated that the parish missed the reporting deadline, there were extenuating circumstances and the parish intends to support the Diocese's mission and ministry.

Tanzania Mission: The Rev. Dr. Sandy McCann reported on the three years she and her husband spent in Tanzania. The Rev Paul Elliot taught in the theological school last year and organized donation of needed items and money, including money from St. Dunstan's, Atlanta. Bishop Alexander visited Tanzania and ordained her to the priesthood. His daughter Kelly is teaching in Africa. The Diocese of Atlanta truly has helped. There are many needs: education, medical care, clean water and agricultural needs. Her husband, Dr. Martin McCann, is a practicing pathologist in Tanzania.

The Rev. Paul Elliot introduced the Very Rev. Dr. Dickson Chilogani, Principal-Dean of Msalato Theological College, Dodoma, Tanzania, who brought greetings from his family, seminary and bishop. He gave thanks for the partnership between the two dioceses, stating that in

Africa, one becomes a full human being in community. Because we are different we can enrich each other. A trust has been established for the Bennett Sims Scholarship program to be administered by the Rev. Paul Elliot. Ten thousand dollars have already been received to start the program.

Janet Patterson, Chair of the Annual Council Committee, gave instructions on receiving lunch.

The Rev. B. Carl Buice, St. James', Macon, led noonday prayers.

Introduction of Resolution R06-7

The Rev. Douglas Hahn, St. Thomas, Columbus, moved Resolution R06-7, Thanks for the Ministry of Presiding Bishop Griswold. The Bishop referred it to the Memorials Committee.

The Bishop recessed the Council for lunch at 12:18 p.m., to reconvene at 1:15 p.m.

Address by Bishop Ramos-Orench

The Bishop invited the Rt. Rev. Wilfrido Ramos-Orench, Bishop Diocesan of Ecuador Central, to come before Council and presented him a copy of the Centennial book about the Diocese of Atlanta. Bishop Ramos-Orench addressed the Council.

Reports of ministries

Appleton Family Ministries: The Rev. Claiborne Jones, Governor-elect, Vicky Partain of Chattahoochee Valley Convocation Episcopal Ministries and The Rev. William Anderson, President of the Board of Governors, reported.

Chattahoochee Valley Convocation Episcopal Ministries: Vicky Partain, Missioner, reported on a project called Infusion, a work in progress.

Mikell Camp and Conference Center: The Rev. Ken Struble, Director, reported, noting the progress in the facilities and program. He solicited support for the Kids for Peace.

Emmaus House: The Rev. Claiborne Jones, Director, reported considerable activity this year and noted that Emmaus House is raffling off a boat and a quilt that was made by Emmaus House seniors.

Holy Comforter's Ministry: The Rev. Mike Tanner, Vicar, reported on this parish's offering of dignity to the poor and disabled. He thanked volunteers and the parish and private contributions that enable the parish to pay its pledge to the Diocesan Ministry and Mission Budget.

Appleton Family Ministries follow up: The Rev. William Anderson, President of the Board of Governors, noted that the Thanksgiving Offering is designated by diocesan canon to support of Appleton.

The Council was in recess from 10:16 to 10:35 a.m.

The offering at the Council Eucharist was \$5,018.68.

The Bishop led the Council in prayer for the Diocese of Arkansas and the Diocese of Southern Ohio that are electing bishops this day.

Episcopal Church Women: Joan MacCumber, President of the Atlanta ECW, reported on the national UTO, announcing grants of \$8,900 to replace the roof on Absalom Jones Chapel, Atlanta and of \$7,000 for the Good Samaritan Health Center at Holy Family, Jasper.

Finance: Stephen Burnett, Chair, discussed the Draft Proposed Budget for Ministry and Mission of the Diocese. He moved the draft proposed budget be approved and forwarded to the Executive Board for final action as required by Canon 20.

Resolved, that the 100th Council of the Episcopal Diocese of Atlanta extend its Companion Diocese Relationship with the Diocese of Rio de Janeiro for a period of three years.

Bishop rescinds request for election of a Bishop Suffragan

The Bishop addressed the Council. A summary of his statement follows. A bishop is a symbol and embodiment of unity within a diocese, part of the one, holy, catholic and apostolic church. Election of bishops should be characterized by the values of unity, joy, common purpose and common expectation. To elect or to propose to elect a bishop when these values are not clear would not be a faithful move. "It has become clear since my address that to proceed with the election of a Bishop Suffragan at this time would be divisive, and therefore I rescind my call for the election of a Bishop Suffragan."

Legislative Committee reports resumed

Constitution and Canons: Richard P. Perry, Esq., Chair, recommended rejection of Resolution R06-1. In view of the Bishop's just announced action, he moved the Committee be discharged from further consideration of all resolutions dealing with the Election of a Bishop Suffragan. [*Resolutions R06-6, C06-1 and C06-2.*]

The Rev. Dan T. Edwards, Dean of Macon Convocation, proponent of Resolution R06-1, moved its withdrawal.

Texts of the resolutions follow.

C06-1

Resolved, that Section 4, Canon 43 of the Canons of the Diocese of Atlanta is amended to read as follows:

Section 4(a.) For the election of a Bishop Diocesan or Bishop Coadjutor, a Committee for Nominations will be formed of one clergy and one lay representative elected from each convocation and one person elected by the Standing Committee from among its members. [Phrase added and Section 4 renumbered Section 4(a).]

Section 4(b) For the election of a Bishop Suffragan, The Diocesan Council that consents to such election shall establish Rules of Order for that election. [added]

R06-2

Resolved, that a Special Rule of Order for the Election of a Bishop Suffragan be adopted, to read as follows:

Sec. 1. In consultation with the Office of the Presiding Bishop of the Church, the Standing Committee of the Diocese of Atlanta will seek the required canonical consents of the Bishops of this Church with jurisdictions, and the Standing Committees of the dioceses of this Church, for the election of a Bishop Suffragan of the Diocese of Atlanta.

Sec. 2. After the consents have been received, and in consultation with the Right Reverend Clayton F. Matthews of the Office of Pastoral Development of the House of Bishops, the Standing Committee will provide to the Diocese a timeline for nominations, interviews, background checks, and related matters by no later than February 1, 2007.

Sec. 3. Because the Canons of the Church require that the Bishop Diocesan set forth the duties that will be assigned to the Bishop Suffragan and because the Bishop Suffragan serves to support the ministry of the Bishop Diocesan, the Standing Committee will carry out its duties under this Rule of Order in close association with the Bishop Diocesan. Persons will be nominated for election as Bishop Suffragan with the consent of the Bishop Diocesan.

Sec. 4. The Standing Committee will present no less than three candidates for election as Bishop Suffragan to the 101st Annual Council as part of its regular proceedings. The Standing Committee shall provide in its timeline an appropriate procedure for additional nominations. Such additional nominees will be added to the slate only after all required reference and background checks have been thoroughly conducted and the consent of the Bishop Diocesan of Atlanta is obtained.

Sec. 5. It is anticipated that the Bishop Suffragan will take office upon her or his ordination to the episcopate. The ordination will take place at the Cathedral of Saint Philip at the earliest possible time under the provisions of the Canons of the Church, and in consultation with the Presiding Bishop, the Bishop of Atlanta, and the Dean of the Cathedral of Saint Philip.

Sec. 6. This Special Rule of Order will expire upon the first to occur of the ordination or installation of the Bishop Suffragan or the withdrawal of the request for a Bishop Suffragan by the Bishop Diocesan.

Committee reports continued

Committee on Bishop's Address: The Rev. Carri Patterson Grindon, Chair, reported as follows.

Greetings, sisters and brothers in Christ! Grace and peace to you, Bishop Alexander. In preparation for this address, I spoke with a friend who encouraged me, and said to me, "Brief is Beautiful". I will try to be as beautiful as I can be.

Right Reverend Sir, first let me say on behalf of my committee that we appreciated both your episcopal address and your episcopal dress.

Bishop, we heard from you yesterday a call to offer ourselves, our souls and bodies, to the work of Christ in the Church and in the world, and we are proud to have a bishop who leads by example. We are so grateful for the way you gave yourself, in spite of your being scared to death, to the possibility of serving as our Church's Presiding Bishop, and all that the process meant for your life, and we are equally grateful it brought you back home. We give thanks that your cincture is tethered to our altar.

A week ago today, at the investiture of our new Presiding Bishop, Katharine Jefferts Schori, the greater Episcopal Church, our Church, ushered in a new season of ministry with power and beauty. And now, here in Atlanta, a week later, with your feet firmly planted on red soil, we hear you calling us to a new season of ministry, a new century of faithfulness to our baptismal vows and to the life of the Gospel.

Bishop, we hear in your words to us a call simply to remember who we are: to remember that we are people for whom a passion for social justice is in our DNA and, as such, people who will always live in solidarity the poor and the marginalized, and will work to bring about a more just society for all people. We accept your call to be about this work actively, through our parishes, our boot camps for the New Jerusalem, and we accept your call to engage seriously in the work of achieving the Millennium Development Goals. And we encourage the Diocese to lead us in this commitment by pledging .7% of its resources to this important work.

We hear you calling us to remember who we are, people who, to our marrow, are people of reconciliation, calling people to the center. We hear this, not as a call to be wishy-washy, but as a call to stand in the center, to live in the tension, to be in relationship with those with whom we disagree, to stay there, holding on to one another, stretching our arms out as wide as they will go.

We hear you calling us to remember that we are the living, breathing Body of Christ. Living things grow. You call us to remember that we are alive in Christ—and so we will grow, we must grow. We say yes to you, Bishop—changing lives is reason enough to grow, and we accept your challenge.

I was struck last weekend in the investiture liturgy by the audacity of our faith—the things we claim we can do with God's help. As Bishop Jefferts Schori received gifts for her ministry, she responded with bold words of challenge.

We are equally struck, Bishop Alexander, by your faith in us and by your audacious call to us here in the Diocese of Atlanta to lead the Church, to lead the Anglican Communion, to make a difference, to change the world.

But you have reminded us who we are and, as Christians, we are nothing if audacious. So we accept your challenge:

To remember who we are, people of audacious hope; and

To get busy changing the world and hawking commemorative coffee table books. Thank you.

Annual Council: Janet Patterson, Chair reported the 101st Annual Council will be held at the Cathedral of St. Philip in Atlanta, Thursday, Friday and Saturday, November 9th, 10th, and 11th, 2007. Because of the invitation to Presiding Bishop Jefferts Schori to attend, Dean Candler invited Council to be at the Cathedral.

Personal privilege

The Rev. John Bolton, Our Saviour, Atlanta, noted he had been omitted from the ordination anniversaries and that he was ordained forty years ago by a non-juring bishop of the Episcopal Church of Scotland. The Bishop noted, "Not actually. On the demise of Charles Edward Stuart in the Eighteenth Century, the Scottish bishops renewed their fealty to the English crown."

Personal privilege

Mr. Ralph NeSmith, St. Matthew's, Snellville asked if a bishop qualified to be Assistant Bishop should become available, could the Bishop bring that person on board. The Bishop replied it would be possible but unlikely.
